Browse the Clean Energy Council's list of approved (fire-tested) solar photovoltaic (PV) modules suitable for installation under the Small-scale Renewable Energy Scheme (SRES). From 1 May 2026, new applications for products to feature on the CEC's approved PV module list must be certified to IEC 61730:2023. Did you Know non-electricians can now become accredited solar & battery designers in Australia?

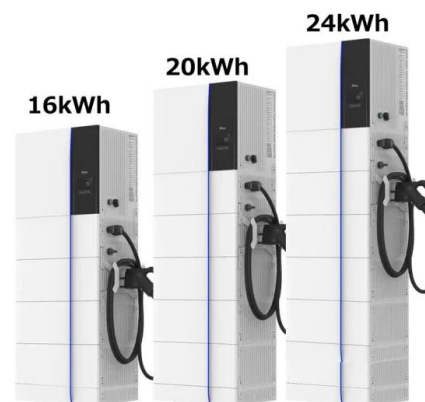
