A new subsidy scheme for residential solar-plus-storage installs is now live in Bavaria. The state in southern Germany will provide EUR500 (US\$550) for a storage system of at least 3kWh and a further EUR100 (US\$110) for each additional 1kWh up to a maximum of EUR3200 (US\$3530).
