The California Energy Commission (CEC) has exclusive authority to license thermal plants 50 MW or larger (AFC), exempt certain small thermal power plants from its jurisdiction, and certify eligible renewable energy generation and energy storage (Opt-in Certification) and Department of Water. 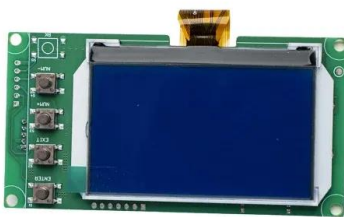
