If the registered title is held jointly, all parties must be reflected as applicants or there should be a letter or authorization from the other title holder(s) giving the applicant permission to use the land for the proposed activity. A fuel storage facility is defined by the NWA Developer's and Investment Manual, Volume 2: Section 1 as one or more stationary tanks along with accompanying fixtures, pipelines or other equipment. Under Section 9 of the Natural Resources Conservation Authority (NRCA) Act, 1991, and the Natural Resources Conservation (Permits and Licences) Regulations, 1996, industrial. 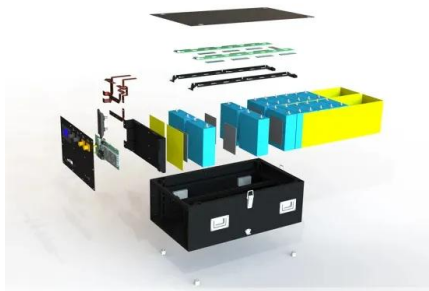
