Sign up your jurisdiction for SolarAPP+ by registering on NREL's SolarAPP+ page SolarAPP+ provides local governments with a standard portal for receiving and processing permit information for residential solar and solar+storage systems. All Skilled Trades and licensed Contractors must register first to use the Department's online permit processing ePermit system. Registered Filing Representatives may prepare applications, but the Applicant must submit the filing and sign/seal all documents, statements and plans, as required. For use in all New York State counties with the exception of Nassau County and Suffolk County. The standardized permit is expected to cut costs by creating a uniform permitting process in municipalities across the State.
