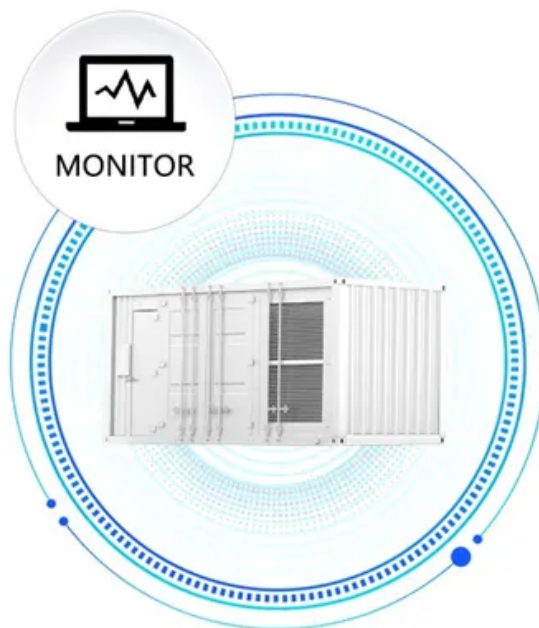

On 2 September 2025, the National Standards Council endorsed 73 standards for adoption as Myanmar Standards (MMS) under Notification No. These standards cover key sectors, including: Electrical and Photovoltaic Systems:. 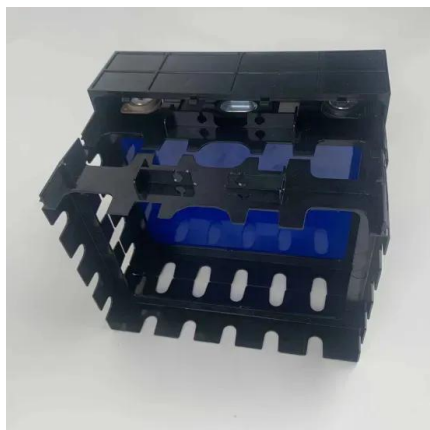

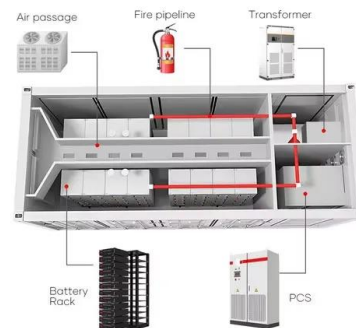
