To be able to import or export products, economic operators must obtain an installation licence from the Ministry responsible for trade; be authorized and enrolled in the Trade and Personal Property Credit Register; be registered in the files of the National Centre for Statistics and. All pre-customs clearances for imports, exports, and transit of goods from pilot sites in Kinshasa, Lubumbashi, Matadi, Goma, Boma, and Kisangani are to be performed on the GUICE's electronic platform at the following website: <https://segucerdc>. 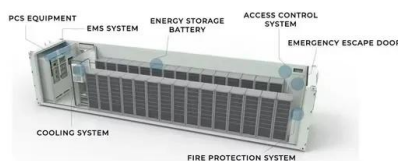
