

Solar container and new energy signed a contract with georgian company





Overview

In a significant move to boost its renewable energy sector, Adjar Energy, a subsidiary of the Turkish conglomerate Eksim Holding, has announced a substantial investment of \$460 million in Georgia. The city's new 140MW photovoltaic + storage project isn't just another solar farm - it's Serbia's first large-scale marriage of solar generation with lithium-ion battery storage. Think of it as a giant power bank for the capital, storing sunshine for cloudy days and moonlit nights. The most common and innovative application is installing solar panels on shipping containers. Precisely configured systems mean you do not need to purchase unnecessary storage capacity. A new mechanism to encourage interest in renewables, contracts for differences (CfDs), will seek to resolve years of disagreement between the state and private sector about who should bear the risk of project development.

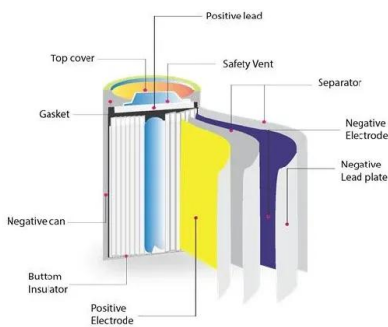
