Bureau of Land Management (BLM) recently released a final rule that will reduce annual rent and capacity fees for wind and solar energy rights-of-way (ROWs), allow noncompetitive leasing in Designated Leasing Areas (DLAs), modify BLM's approach to. 18 What terms and conditions apply to a solar and wind energy development lease?
