A Solar Power Purchase Agreement (SPPA) is a financial arrangement in which a third-party developer owns, operates, and maintains the photovoltaic (PV) system, and a host customer agrees to site the system on its property and purchases the system's electric output from the solar services provider. International Renewable Energy Agency (IRENA) and Terrawatt Initiative (TWI) have teamed up to support the rapid and widespread scale-up of solar energy in line with goals of the Paris Climate Agreement and Sustainable Development Goals. For Solar Projects, PPA delineates the terms under which the energy generated by the solar project will be sold.

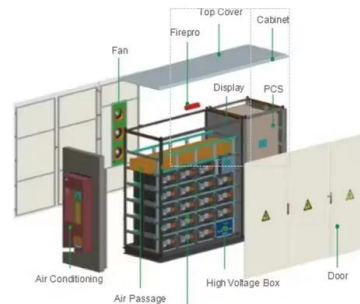

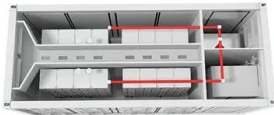
