Restructurings in some cases loom as prospects for the sector dim under a new presidential administration scuttling government programs that had. Canadian Solar is executing a strategic reorganization to consolidate control over its North American manufacturing and sales, aiming to build a more resilient and transparent domestic supply chain. 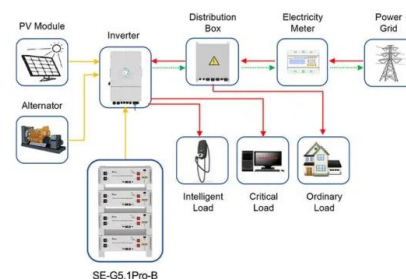
