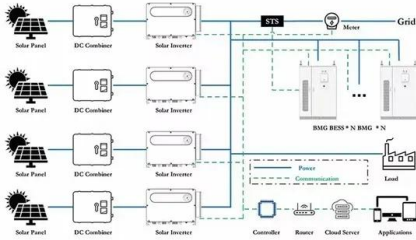


Overview

US President Joe Biden has increased the tariff rate quota (TRQ) for imported solar cells under Section 201 from 5 GW annually to 12. Crystalline Silicon Photovoltaic (CSPV) Cells and Modules as specified in Presidential Proclamation 10339 of February 4, 2022. From revised federal guidance on the Investment Tax Credit (ITC) to state battles over net metering and renewable standards, these updates will shape the trajectory of solar deployment nationwide.
